

LOCATION

- Five minute drive to Downtown Antigonish

- Construction of twinning Highway 104, between Sutherlands River, Pictou County and Antigonish, has commenced and is scheduled to be completed before the end of 2023
- St. Francis Xavier University, one of Canada's top ten primarily undergraduate universities, is located in Downtown Antigonish

- St. Martha's Regional Hospital, a five minute drive from the site, provides service to the residents of Antigonish, Guysborough, Richmond and Inverness Counties
- Parkland Retirement Living, a multitiered senior support living complex, is within an eight minute drive
- Antigonish's hosts several annual festivals, including the well-known The Highland Games Festival
- Surrounding areas of Antigonish are well-known for their prosperous farming and fishing industries





MASTER PLAN

The nine developed lots are serviced by two paved roads, Catherine Drive and MacGillivray Way, to provide convenient access for businesses.

Century Nissan is East Gate Ridge's first tenant. This strong-covenant tenant completed their sophisticated 12,000 sf building, located on approximately 3.5 acres, in Spring 2020.


